## SCHOOL DAYS, SCHOOL DAYS - DEAR OLD GOLDEN RULE DAYS

California Humane Educators! Don't miss this opportunity to take the golden rule of "reference for all forms of life" into your local schools. Many schools already have School Site Councils and others are in the process of forming them. The councils (set up and funded under AB 65) are comprised of school personnel, parents, and community leaders. Their purpose is to review current curriculum and make suggestions for its improvement. If you are unable to get appointed to a council, you can offer to speak to them about the importance of humane education to the development of children and the fact that it is mandatory under Section 13556.5 of the California Education Code. The Animal Care Center, P.O. Box 64, Rancho Santa Fe, CA 92067 is introducing a new Pet Saver program. For a donation of \$2. you receive two brightly printed stickers reading "Animal on Premises" and a pet owner's wallet identification card. The stickers have a space to list all your animals and are posted at the entrances of your residence to alert firefighters or other rescue workers to the animals being in the house. The identification card provides pertinent emergency information on you and your pets should something happen to you while you are away from home. The stickers have received the endorsement of Chief James A. Fox of the combined Rancho Santa Fe-Solana Beach Fire Dept.
